      - 1,338 library visits (+4.9% from last year); 2,535 items circulated (-0.4% from last year);
        28% of circulation was digital; 179 program attendees (-10% from last year)
    - October statistics:
      - 1,767 library visits (-2.5% from last year); 2,994 items circulated (+1.1% from last year);
        28.1% of circulation was digital; 570 program attendees (+17.3% from last year)
    - 37 people attended the Community Read Fahrenheit 451 on October 6th; majority of cost covered by grants and donations
    - Outreach efforts included face painting at Utterback School during their Fall Festival and Trunk-or-Treat with Curious George decorations
    - Public Library Survey Statistics have been submitted; the Board received correspondence from State Librarian Jennie Stapp regarding outreach programs; Tiffany reported a state safety inspection and resulting maintenance projects
